b.	Is the procuring entity really requiring the bidders and eventually the winning contractor to ensure the availability of the Nominated Equipment for the duration of the project?	The Statement of Availability of Equipment shall certify that the contractor commits the nominated equipment which may be owned, leased, and/or under purchase agreement for the project. However, utilization of all equipment will depend on the Contractor's construction methodology and schedule.
	reollED N	Likewise, the TWG shall verify, inspect and/or test during post-qualification for the required capacities and operating conditions of equipment units to be owned/leased/under purchase by the bidder for use in the contract under bidding.
c.	What type of design technology and requirements are needed for designing STP?	Please refer to Section VI Specifications of the bidding documents.
d.	What are the structural detail plan requirements?	Please refer to Section VI Specifications of the bidding documents.

2. Other Clarifications

a. Prospective bidders must have at least a Category A and License Classification Medium B either for General Engineering-1, **General Building-1**, General Building-2, or General Building-3 from the Philippine Contractors Accreditation Board (PCAB). The PCAB license must be valid and effective at the time of submission of the bid.
