RESOLUTION OF AWARD (RESO NO. BG-LBI 2021-0010)

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through the downloaded funds from the Department of Information and Communications Technology (DICT), has bidded out the Procurement of Supplies, Services, and Equipment for the International Cable Landing Stations, Repeater Stations Facilities, and Luzon Bypass Infrastructure Operation with the following Approved Budget for the Contracts (ABCs), inclusive of Value-Added Tax (VAT) and all other applicable government taxes, fees, and other charges for the following Lots:

WHEREAS, on 19 January 2021, the BAC for Goods, through its Secretariat, publicized/advertised the Invitation to Bid in the following:

- 1. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- 2. BCDA Website;
- 3. Newspaper of general circulation; and
- 4. Conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, during the Opening of Bids on 09 February 2021, the BAC-G has received a bid proposal for **Lot D**. However, for **Lots A**, **B**, **and C**, no bids were received by BAC-G. Subsequently, the BAC-G declared a failure of bidding for Lots A, B, and C through **BAC-G Resolution No. BG LBI 2021-005**, pursuant to Section 35.1 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, to wit:

"35. 1. The BAC shall declare the bidding a failure when:

- a) No bids received;
- *b) xxx;*
- c) xxx;
- d) xxx.







WHEREAS, the BAC-G opened the bid proposal submitted by Dark Horse Security Agency, Inc. for the Procurement of Lot D and found it to be eligible, thus BAC-G proceeded with the opening of its financial proposal.

WHEREAS, after preliminary evaluation of the submitted bid, BAC-G found Dark Horse Security Agency, Inc. to have: (i) passed the eligibility requirements and technical proposal; and (ii) submitted a financial proposal in the amount of Seven Million Six Hundred Twenty Three Thousand Four Hundred Eighty Two Pesos and 45/100 (Php7,623,482.45), inclusive of government taxes and fees, which is below the ABC for Lot D. Thus, the BAC-G declared Dark Horse Security Agency, Inc. as the Single Calculated Bid for the Procurement of Lot D of Supplies, Services, and Equipment for the International Cable Landing Stations, Repeater Stations Facilities, and Luzon Bypass Infrastructure Operation.

The Abstract of Bids is hereby attached as "Annex "A".

WHEREAS, DICT submitted to BCDA a letter dated 26 February 2021 with an attachment indicating the General Conditions and Areas of Responsibility of the Security Services for the Two (2) International Cable Landing Stations and four (4) Repeater Stations Facilities in connection with the Procurement of Lot D.

WHEREAS, in view of the foregoing and consistent with Section 34 of Rule X – Post-Qualification of the Revised IRR of Republic Act No. 9184, the BAC-G Technical Working Group (TWG) submitted the Post-Qualification Report dated 31 March 2021.

WHEREAS, upon post-qualification conducted by the BAC-G TWG and after careful examination, validation, and verification of all the eligibility, technical, and financial documents submitted by Dark Horse Security Agency, Inc., BAC-G found that all documents are in order.

The Post-Qualification Report is hereby attached as **Annex** "**B**".

WHEREAS, BAC-G issued a Bid Bulletin No. BAC-G LBI 2021-002 revising the schedule of the remaining bidding activities to provide more time to the Department of Information and Communication Technology (DICT) to prepare and submit a Report on the Status and Inventory of the Cable Landing Stations and Repeater Facilities (Inventory Report) before the engagement of the Security Services.

WHEREAS, BAC-G further issued a Bid Bulletin No. BAC-G LBI 2021-003 extending the deadline of the issuance of the BAC-G Resolution for the award of the contract for Lot D from 06 March 2021 to 30 March 2021 to provide more time for the Office of the Government Corporate Counsels (OGCC) to complete its review of the draft Contract for Lot D (Security Services) of the Supplies, Services, and Equipment for the International Cable Landing Stations, Repeater Station Facilities and Luzon Bypass Infrastructure Operations. The draft Contract has been submitted by BCDA for review and comments of theOGCC, BCDA's statutory counsel pursuant to Executive Order No. 596, series of 2006. The OGCC's comments, corrections, and revisions shall be incorporated into the final copy of the Contract to be executed between the BCDA and winning bidder for Lot D.

WHEREAS, BAC-G further issued a Bid Bulletin No. BAC-G LBI 2021-004 extending the deadline of the issuance of the BAC-G Resolution for the award of the contract for Lot D from 30 March 2021 to 14 April 2021 to provide more time for the Joint BCDA and DICT Inventory Team to submit a Report on the Status and Inventory of the Cable Landing Stations and Repeater Station Facilities.
