	QUERIES	CLARIFICATION/S
1.	May we clarify on the copies of bid documents to be submitted. Is it right that BAC-G requires 1 original and 1 copy of the documents for this project?	Per the RIRR of RA 9184 and GPPB Issuances, only one (1) copy of the eligibility, technical, and financial documents is required during the submission of bid proposals.
2.	What does the SLCC refer to? Does it refer to cargo vehicles, or any 4-wheeled vehicle?	Per the Bidding Documents, a similar completed contract refers to any four (4) wheeled vehicle, cargo, van, or SUV.
3.	For the purpose of clarification, for our Section 6- Schedule of Requirements, for the delivery period, it is 90 days effective from the receipt of Notice to Proceed not the receipt of the Purchase Order.	Per Section VI. Schedule of Requirements of the Bidding Documents, the delivery schedule for the Three (3) units of Brand New Cargo Vehicle must be completed within ninety (90) days from the receipt of Notice to Proceed (NTP) by the supplier.

4.	 Please clarify on other requirements such as : a. Location of Service Centers; and b. Free labor on periodic maintenance service check-up 	The dealer must have available service centers in the entire Luzon Island. The dealer must offer free labor on periodic maintenance service for the first 1,000 kms., 5,000 kms., and 10,000 km check-up.
