ZOSA, who is duly authorized for this purpose under item 159 of the BCDA Manual of Approval duly approved by the BCDA Board on 22 November 2017, a copy of which is hereto attached as Annex "A", hereinafter referred to as "BCDA";

POSITIVE BUILDERS AND TRADING, a private corporation duly organized and existing under the laws of the Republic of the Philippines, with office address at Plaza San Nicolas 1st, Lubao, Pampanga, represented herein by its Authorized Representative, **RYAN M. CALADIAO**, who is duly authorized for this purpose as evidenced by the Special Power of Attorney dated 15 October 2021, a copy of which is hereto attached as **Annex "B"**, herein after referred to as "**Contractor"**.

Individually referred to as "Party" and collectively as "Parties."

ANTECEDENTS

BCDA is desirous that the Contractor execute the Design and Construction of DOE's Water, Sewer and Drainage System in Bonifacio Global City (hereinafter called "the Works") and the Entity has accepted the Bid for Pesos: Twenty Million Three Hundred Fifty One Thousand Six Hundred Fifty and 00/100 (Php 20,351,650.00) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

ACCORDINGLY, the Parties agree as follows:

- In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, *viz*.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Terms of reference
 - ii. Drawings/Plans;

 - iv. Bill of Quantities;
 - v. General and Special Conditions of Contract;
 - vi. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial

Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and

- 3. In consideration for the sum of Php 20,351,650.00 or such other sums as may be ascertained, the Contractor agrees to execute the Design and Construction of DOE's Water, Sewer and Drainage System in Bonifacio Global City in accordance with his/her/its Bid.
- 4. The BCDA agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
- 5. Any amendment, modification or additional terms and conditions to this Contract shall be made in writing and executed with the same formalities hereof.
