## RESOLUTION NO. BG-NAS-2021-003 FAILURE OF BIDDING FOR LOT D

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) has bid out the Supply, Delivery and Installation of Goods (Furniture and Equipment) for the National Academy of Sports (NAS) – Phase 1 at New Clark City with the Approved Budget for the Contract (ABC) of One Hundred Thirty Million One Hundred Sixteen Thousand Pesos and 00/100 (PhP130,116,000.00), inclusive of all applicable government taxes and fees, through the General Appropriations Act (GAA), broken down as follows:

**WHEREAS**, on 10 November 2021, the Bids and Award Committee for Goods (BAC-G), through its Secretariat, advertised the Invitation to Bid in the following:

- 1. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- 2. BCDA Website; and
- 3. Conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, in response to said advertisement, only one (1) proponent, JYM Enterprises, submitted its bidding proposal for Lot D before the deadline of submission on 03 December 2021 at 12:00 PM;

**WHEREAS,** during the Opening of Bids, BAC-G received and opened the bidding documents submitted by **JYM Enterprises** and noted that the bidder failed to submit the complete





eligibility and technical documents. Therefore, it was declared non-eligible. Pursuant to Section 25.2. (a) vii of the RIRR of RA 9184, its financial proposals were left unopened:

**WHEREAS**, in view of the result of the Opening of Bids on 03 December 2021, the Bids and Awards Committee has declared **JYM Enterprise** as ineligible for its bid for **Lot D**; (Abstract of Bids is hereby attached as "Annex "A")

**WHEREAS,** on 07 December 2021, BAC-G sent a Notice of Ineligibility to **JYM Enterprise** informing that **JYM Enterprise** has failed to submit the 2020 Audited Financial Statement as required in the bidding documents and that made it ineligible for the project. *(hereby attached as Annex "B")* 

**WHEREAS, JYM Enterprise** filed a Motion for Reconsideration on 09 December 2021 via email on the decision of BAC-G declaring **JYM Enterprise** as ineligible in relation to its failure to submit the required 2020 Audited Financial Statement; (hereby attached as **Annex** "C")

WHEREAS, during its meeting on 13 December 2021, BAC-G has reiterated its decision that the non-submission of the 2020 Audited Financial Statement as required in the bidding document and bid bulletin No. BACG-NAS-2021-01 has rendered JYM Enterprises as ineligible for Lot D;

WHEREAS, on 16 December 2021, BAC-G sent a Response Letter to JYM Enterprise (hereby attached as Annex "D") ") informing JYM Enterprise with the BAC-G's final decision to deny its Motion for Reconsideration and declare JYM Enterprise as ineligible for Lot D, with the following reasons, to wit;

To direct the end-user to conduct a mandatory review and evaluation of the terms, conditions, and specifications for the Procurement of the Supply, Delivery and Installation of Goods (Furniture and Equipment) for the National Academy of Sports (NAS) – Phase 1 at New Clark City, pursuant to Section 35.2 of the Revised IRR of RA 9184; and

**RESOLVED,** at the BCDA Corporate Center Office, this 29 December 2021.
