### DECLARATION OF BIDDER WITH THE HIGHEST RATED AND RESPONSIVE BID

## Consulting Services for the Construction Management and Supervision (CMS) of Special and Technical Staff Building for SSC and DACC at Fort Bonifacio, Taguig City

**WHEREAS,** On 18 October 2019, the Bids and Awards Committee for Consultancy (BAC-C) advertised the Request for Expression of Interest (REI) for the said consulting services in a newspaper of general nationwide circulation, in the BCDA Website, PhilGEPS Website and in a conspicuous place in the premises of BCDA continuously for seven (7) days;

WHEREAS, the consulting services has an Approved Budget for the Contract (ABC) amounting to Twenty Six Million Three Hundred Sixty Four Thousand Eight Hundred and 00/100 (PhP26,364,800.00), inclusive of all applicable taxes and fees, to be completed within seventeen (17) months;

**WHEREAS,** on 14 February 2020, the Bids and Awards Committee for Consulting Services (BAC-C) issued BAC-C RESOLUTION NO. BC2020-007, declaring Filipinas Dravo Corporation as the bidder with the Highest Rated Bid (HRB) for the above mentioned Consultancy Service. Likewise, the said resolution resolved to proceed with the negotiation with the HRB;

**WHEREAS,** negotiation with the HRB was conducted on 02 March 2020, pursuant to Section 22.2.5 of the revised IRR of RA 9184;

**WHEREAS,** after the conduct of successful negotiation, pursuant further to RA 9184 revised IRR, the Technical Working Group (TWG) conducted post-qualification activities to verify, validate and ascertain all statements made and the documents submitted by the HRB;

**WHEREAS,** on 03 March 2020, the results of the post qualification activities conducted by the TWG are as follows:

- 1. The official address of **FILDRAVO** at 5th Floor Aurora Milestone Building, 1045 Aurora Blvd, Quezon City as validated during an ocular visit at the office.
- FILDRAVO is compliant with the labor laws such as the latest payment to SSS, PhilHealth, and Pag-ibig Fund, upon verification of original copies of Class A legal documents. Supporting documents for completed and on-going projects were also found to be legitimate.
- 3. The nominated key personnel have sufficient work experiences as stated in their curriculum vitae based on the conduct of interviews through on-line platforms (google meet/zoom) and phone calls.

4. Previous clients have positive feedback on the performance of FILDRAVO when verified through phone calls.

**WHEREAS**, The BACC-TWG members and its provisional members recommended to declare the bid of FILDRAVO as Highest Rated And Responsive Bid (HRRB).

**WHEREAS,** the CMS contract should have been awarded not later than 27 April 2020, following the three (3)-month period from opening of bids up to the award of the contract as prescribed by the IRR of RA 9184.

**WHEREAS,** the imposition of the Enhanced Community Quarantine by the National Government resulted in the postponement of all procurement activities undertaken by the Bids and Awards Committee for Consulting Services.

**WHEREAS,** the award of the CMS contract should be simultaneous to the award of the construction project because there is nothing to manage and supervise if there is no construction yet.

WHEREAS, BAC-C RESOLUTION NO. BC-2020-026 dated 21 October 2020 was released suspending the award of the contract to **FILDRAVO** for the Consulting Services for the Construction Management and Supervision (CMS) of ASCOM Facilities at Camp Aquino, Tarlac until such time that the bidding of the construction component of the project has successfully been awarded to the winning bidder. FILDRAVO has submitted an updated Bid Security;

**WHEREAS**, on 06 July 2021, the end-user notified the Bids and Awards Committee that the award to the winning bidder of the construction component of the project will be completed already;

**NOW, THEREFORE,** after deliberation and premises considered, we, the members of the Bids and Awards Committee for Consulting Services, hereby resolve to recommend the approval of the following:

- DECLARE Filipinas Dravo Corporation as the bidder with the Highest Rated and Responsive Bid (HRRB) for the Consulting Services for the Construction Management and Supervision (CMS) of Special and Technical Staff Building for SSC and DACC at Fort Bonifacio, Taguig City;
- AWARD the Contract to Filipinas Dravo Corporation in the amount of Pesos: Twenty Five Million Seven Hundred Forty Seven Thousand Six Hundred Eighty and 00/100 (Php25,747,680.00), inclusive of all applicable taxes and fees;
- 3. Require the end user to furnish the BAC-C Secretariat original copies of the duly conformed Notice of Award, Executed Contract and Notice to Proceed.
- 4. DIRECT the end user to secure the issuance of the Certificate of Funds Availability (CFA) for the procurement prior to the award of the contract;







- 5. DIRECT the end-user to furnish the BAC-C copies of the duly conformed Notice of Award, Notice to Proceed and executed contract, and all supporting documents pursuant to the procurement; and
- 6. DIRECT the end-user to submit to the BAC-C an evaluation of the performance of the consultant at the end of the contract.

## I. BACKGROUND

Pursuant to the approved BAC-C Resolution No. BC2020-007 dated 14 February 2020, **Filipinas Dravo Corporation** was declared as the Highest Rated Bid (HRB) for the Consulting Services for the Construction Management and Supervision of Special and Technical Staff Building for SSC and DACC at Fort Bonifacio, Taguig City.

The HRB was determined by adopting Quality-Cost Based Evaluation (QCBE) procedure. Filipinas Dravo Corporation was then invited to the Opening of the Financial Proposal. The financial proposal of Filipinas Dravo Corporation in the amount of Pesos: Twenty Five Million Seven Hundred Forty Seven Thousand Six Hundred Eighty and 00/100 (Php25,747,680.00), inclusive of all applicable taxes and fees was found to be within the Approved Budget for the Contract (ABC).

The ABC is Pesos: Twenty Six Million Three Hundred Sixty Four Thousand Eight Hundred and 00/100 (Php26,364,800.00), inclusive of all applicable taxes and fees.

Negotiation with the HRB was conducted on 02 March 2020, pursuant to Section 33.2.5 of the revised IRR of RA 9184.

Based on the foregoing, the Technical Working Group (TWG) conducted the post-qualification activities to verify, validate, and ascertain all statements made and documents submitted by Filipinas Dravo Corporation.

## II. POST QUALIFICATION

After careful examination, validation, and verification of all the eligibility, technical, and financial documents submitted by Filipinas Dravo Corporation, the TWG finds the bidder responsive to BCDA's requirements. The TWG respectfully reports the conduct of the following activities in aid or post qualification:

- 1. On 03 March 2020, the TWG conducted an ocular visit at the office of Filipinas Dravo Corporation in Quezon City to validate the original copies of Class A legal documents, documents in compliance with labor law such as latest payment to SSS, PhilHealth, and Pag-ibig Fund, and supporting documents for completed projects.
- 2. Also, the TWG conducted interviews with the nominated key personnel to validate work experiences stated in their Curriculum Vitae.
- 3. Further, the TWG verified positive feedback from their clients on their performance of services from their completed and ongoing projects through phone calls.

## **III. RECOMMENDATION**
