The BAC-I of BCDA, in line with the Updated COVID-19 Guidelines in BCDA Offices, would like to ensure that preventive efforts and measures are observed during the Pre-Bid Conference for the above mentioned projects to be held on 22 December 2022. The Repair and Repainting of Bicycle Lanes will start at 9:00am and the Provision of Road Signages, Wayfinders, Parking Markings and Fabrication of Steel Barriers will be at 11:00am.

The bidders or their representatives are advised of the following arrangements during the said activity:

- 1. <u>Strictly</u> one (1) representative per bidder/Joint Venture/Consortium is allowed to enter the BCDA premises and attend the Pre-Bid Conference for the project.
- 2. The prospective bidder/representative shall scan their temperature at the BCDA office entrance. Any person with a temperature of 37.5° C and above shall not be allowed to enter the BCDA premises.
- 3. The prospective bidder/representative shall be required to present <u>full vaccination</u> <u>cards/certificates</u> upon entry of the BCDA premises.
- 4. The prospective bidder/representative shall be guided to the BCDA Lobby Hall at BCDA Corporate Center, 2/F Bonifacio Technology Center, Bonifacio Global City, Taguig during pre-bid conference.
- 5. The prospective bidder/representative shall wear his well-fitted face mask and shall ensure that social distancing is maintained at all times.
