This Bid Bulletin clarifies the queries that were raised during the Pre-bid Conference on 02 December 2022 at 9:00 AM and queries sent through e-mail by prospective bidders, as well as other matters relative to the **Procurement of the Data Center and Structured Cabling Rehabilitation at Bonifacio Technology Center**.

QUERIES	CLARIFICATION/S
1. Clarification on the venue, date, and time of the Submission of Bids of the prospective bidders	The bidders may submit their bids on the following schedule and venue: 1) On or before 5:00 PM on 13 December 2022 (Tue) at BCDA Central Receiving and Releasing Area, BCDA Office, Bonifacio Technology Center, Bonifacio Global City, Taguig City; OR 2) On or before 9:00 AM on 14 December 2022 (Wed) at BCDA Central Receiving and Releasing Area, BCDA Office, 9th Floor, One West Aeropark Bldg., Clark Global City
2. Is this project capable of Disaster Recovery System?	YES. This is capable of a Disaster Recovery System but this is not included in the Project's requirements.
3. Clarification in the Instruction to Bidders Section 10. <i>10.1. The Bidder's SLCC as indicated in ITB Clause 5.3 should have been completed within three (3) years from the date of submission and receipt of bids, a contract similar to the Project.</i> Is the three (3) years required?	YES. For SLCC The Bidder must have completed a single contract that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC, within the past three (3) years prior to the date of submission and receipt of bids. Similar Project refers to Data Center and Structured Cabling installation and provision of network equipment.
4. Does the procuring entity need a specific brand - Cisco as Specified in the Technical Specifications for the Existing c9200 Distribution Switch?	YES. This pertains to item 2B, in which we need the 4x10G Network Module of BCDA's existing C9200 Switch.
5. Clarification of the quantity of licenses for the Controller of the additional access points: <i>"Access Points (additional units, to be merged to the existing Ruckus AP units</i>	Additional two (2) licenses for the Controller of the additional access points are required.

through the Zonedirector WiFi controller)"	
6. Clarification if the required Delivery Schedule of the Goods can be adjusted.	The winning bidder must deliver the Goods within 120 Calendar Days.
7. Clarification on the Schedule of the Site Survey in relation to the procurement	The prospective bidders may refer to the following dates for the Site Survey: a. 06 December 2022 (Tue) (8:00AM-5:00PM) b. 09 December 2022 (Fri) (8:00AM-5:00PM) c. 12-13 December 2022 (Mon-Tue) (8:00AM-5:00PM)
8. How many original copies do we need to submit for the Eligibility documents	Each Bidder shall submit one (1) original copy of the first and second components of its Bid, enclosed in one big/mother envelope [Revised PBD, Instruction To Bidder (ITB) Section 15]
9. Where should we purchase the bidding documents?	You can purchase the bidding docs through online just email bacgsecretariat@bcda.gov.ph or go to BCDA BTC Taguig office. You can also check the PhilGEPS/BCDA Website to view the bidding documents before purchase.

The above changes further amend the bidding documents, accordingly. **The Opening of Bids will be conducted face-to-face at the BCDA 9F One West Aeropark Building Industrial Estate - 5, Clark Global City Clark Freeport Zone, Mabalacat 2023 Pampanga** but the bidders may choose to attend the Opening of Bids in person or online, via zoom.

For those who are attending in person, the following guidelines must be followed:

- A maximum of two (2) persons per participating bidder are allowed to attend the Opening of Bids and shall be required to follow the BCDA Health Protocol for Visitors;
- The representative is required to present his/her vaccination card before he/she can be allowed inside the BCDA office;
- Compliance to social distancing, wearing of face masks, and body temperature screening inside BCDA office must be observed; and

- Observers/representatives who show signs of COVID-19 related symptoms such as cough, flu, fever, high body temperature, and sneezing are advised not to proceed to the BCDA Office since they will not be allowed to enter the BCDA premises.
