**Procurement of Consulting Services for the Production of the  
BCDA 2022 Annual Report  
(Declaration of Failure of Bidding)**

**WHEREAS**, the Bases Conversion and Development Authority (BCDA) is mandated under Republic Act No. 7227, as amended by Republic Act No. 7917, to accelerate the sound and balanced conversion into alternative productive uses of the Clark and Subic military reservations and their extensions, to raise funds by the sale of portions of Metro Manila Military Camps and to apply said funds for the development and conversion into alternative productive uses of these properties;

**WHEREAS**, on 27 October 2022, the BCDA, through its Bids and Awards Committee for Consulting Services (BAC-C), posted a Request for Expression of Interest (REI) in PhilGEPS, the BCDA Website, and in a conspicuous place within the premises of BCDA the Procurement of Consulting Services for the Production of the BCDA 2022 Annual Report under Section 10 "Competitive Bidding" of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) No. 9184, with an Approved Budget for the Contract in the amount of **Pesos: One Million Two Hundred Thousand and 00/100 (PhP 1,200,000.00)**, inclusive of all applicable taxes, fees, and incidental expenses.

**WHEREAS**, the BAC-C has conducted a Pre-Eligibility Conference on 4 November 2022 which was attended by the following prospective bidders:

- a. Halcyon Digital Media
- b. Project V Media Group
- c. OP Communications
- d. Anino Design

**WHEREAS**, on 21 November 2022, the scheduled date of Opening of Eligibility Documents, the BAC-C received the eligibility documents of one (1) bidder, Project V Media Group;

**WHEREAS**, the eligibility documents of Project V Media Group was received at 3:06 p.m. at the BCDA Central Receiving and Releasing Area, which is after the deadline of 3:00 p.m.;

**WHEREAS**, the BAC-C received no bids on or before the deadline of 3:00 p.m. on 21 November 2022;

**WHEREAS**, the BAC-C declared a failure of bidding for the Procurement of Consulting Services for the Production of the BCDA 2022 Annual Report pursuant to Section 35.1 of the 2016 RIRR of RA No. 9184, to wit:

*“35. 1. The BAC shall declare the bidding a failure when:*


- a) No bids are received;*
- b) xxx;*
- c) All bids fail to comply with all the bid requirements...;*
- d) xxx.*

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee for Consulting Services, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

1. To declare a Failure of Bidding for the **Procurement of Consulting Services for the Production of the BCDA 2022 Annual Report**; and
2. To direct the end-user, Public Affairs Department, to conduct a mandatory review and evaluation of the terms, conditions, and specifications of the Bidding Documents, including the cost estimates, and other requirements relative to this procurement, pursuant to Section 35.2 of the 2016 RIRR of RA 9184.
