RESOLUTION NO. BG-ISSE-2022-01

The **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)**, through the CY 2022 Corporate Operating Budget (COB), has undertaken the **Procurement of the Annual Subscription of Integrated Security Suite - Endpoint Security** with an Approved Budget for the Contract (ABC) of **Two Million Two Hundred Thousand Pesos and 00/100 (PhP 2,200,000.00)**, inclusive of VAT and all other applicable government taxes and fees;

WHEREAS, the Bids and Awards Committee for Goods (**BAC-G**), through its Secretariat, advertised/posted the Invitation to Bid including the bidding documents on 20 October 2022 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G conducted the Pre-bid Conference on 27 October 2022 which was attended by one (1) prospective bidder, **CT Link Systems, Inc.**;

WHEREAS, in response to said advertisements, **CT Link Systems, Inc.** submitted bids before the deadline on 11 November 2022;

WHEREAS, during the Opening of Bids on 11 November 2022 at 10:00 AM, BAC-G received and opened the bidding documents of the sole bidder - **CT Link Systems, Inc.**, noted it passed the eligibility and technical proposal requirements;

WHEREAS, the single bidder is eligible and passed the initial evaluation of the eligibility and technical requirements, its financial proposal was opened and BAC-G noted the following:

The Post-Qualification Report is hereby attached as Annex "C".


NOW, THEREFORE, We, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**:
