Procurement of Consulting Services for the Conduct of the BCDA Stakeholders' Appreciation Night (Declaration of Failure of Bidding)

WHEREAS, the Bases Conversion and Development Authority (BCDA) is mandated under Republic Act (RA) No. 7227, as amended by RA No. 7917, to accelerate the sound and balanced conversion into alternative productive uses of the Clark and Subic military reservations and their extensions, to raise funds by the sale of portions of Metro Manila Military Camps and to apply said funds for the development and conversion into alternative productive uses of these properties;

WHEREAS, on 27 May 2023, the BCDA, through its Bids and Awards Committee for Consulting Services (BAC-C), advertised a Request for Expression of Interest (REI) in a newspaper of general nationwide circulation, and posted it in PhilGEPS, the BCDA Website, and in a conspicuous place within the premises of BCDA for the Procurement of Consulting Services for the Conduct of the BCDA Stakeholders' Appreciation Night under Section 10 "Competitive Bidding" of the 2016 Revised Implementing Rules and Regulations (RIRR) of RA No. 9184, with an Approved Budget for the Contract in the amount of Pesos: Five Million and 00/100 (PhP 5,000,000.00), inclusive of all applicable taxes, fees, and incidental expenses;

WHEREAS, in response to the said advertisement of REI, one (1) prospective bidder submitted their Eligibility Documents for the Consulting Services for the Conduct of the BCDA Stakeholders' Appreciation Night prior to the set deadline for submission on 30 June 2023 at 10:00 a.m., to wit:



WHEREAS, the submitted Eligibility Documents of COMS 360, Inc. was opened to determine the presence or absence of the required documents using non-discretionary "pass/fail" criterion on 30 June 2023 at 10:30 a.m.;

WHEREAS, the submitted Eligibility Documents of COMS 360, Inc. were subjected to detailed evaluation and shortlisting on 1 to 6 July 2023 in accordance with Section 24 of the 2016 RIRR of RA No. 9184, and using the criteria and rating system for shortlisting as provided under Clause 9.2 of Eligibility Data Sheet (EDS) for the consulting services;

WHEREAS, the Technical Working Group (TWG) presented the results of the evaluation of the Eligibility Documents and shortlisting, and the BAC-C deliberated the results on 7 July 2023:

WHEREAS, the results of the Evaluation/Eligibility Check and Shortlisting likewise show that COMS 360, Inc. was rated "FAILED" and garnered a total score of 53.30% with breakdown as follows:

- 1. Declare a Failure of Bidding for the Procurement of Consulting Services for the Conduct of the BCDA Stakeholders' Appreciation Night;
- 2. Issue a Notice of Ineligibility to COMS 360, Inc. and
- 3. Direct the end-user, Investment Promotions and Marketing Department, to conduct a mandatory review and evaluation of the terms, conditions, and specifications of the Bidding Documents, including the cost estimates, and other requirements relative to
