BIDDING FOR MANPOWER SERVICES OF THE BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) UNDER A TWO-YEAR SERVICE AGREEMENT (CONSISTING OF TWO LOTS)

### RESOLUTION OF AWARD (RESO NO. BG-2018-018)

**WHEREAS**, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) has put on bid the **BIDDING FOR MANPOWER SERVICES FOR THE BCDA UNDER A TWO-YEAR SERVICE AGREEMENT (CONSISTING OF TWO LOTS)** with an Approved Budget for the Contract (ABC) of **Pesos: Seventy-Six Million Three Hundred Thousand & 00/100 (Php76,300,000.00)**, inclusive of all applicable taxes and fees.

**WHEREAS**, the BAC for Goods, through its Secretariat, advertised the Invitation to Bid on 19 June 2018 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA

**WHEREAS**, in response to said advertisements, only one (1) company, **DBP Service Corporation (DBPSC)** bought the bid documents for both Lots.

**WHEREAS**, on 09 July 2018, on the scheduled Opening of Bids, the BAC for Goods received one (1) proposal for each of the Two Lots from DBPSC. During this event, DBPSC, having submitted the required eligibility documents was found eligible, thus, its financial proposal was opened.

**WHEREAS**, DBPSC submitted bids for both Lots of the **BIDDING FOR MANPOWER SERVICES FOR THE BCDA UNDER A TWO-YEAR SERVICE AGREEMENT** in the following amounts:

- a. Lot 1: Manpower Services for General Support and Janitorial Services in the amount of **Pesos: Eighteen Million Eight Hundred Eighty-Six Thousand Seven Hundred Ninety & 40/100 (Php18,886,790.40)**, inclusive of all applicable taxes and fees; and
- b. Lot 2: Manpower Services for Technical and Administrative Support Services in the amount of **Pesos: Fifty Three Million Six Hundred Forty-Nine Thousand One Hundred Seventy-Two & 80/100 (Php53,649,172.80)**, inclusive of all applicable taxes and fees. *The Abstract of Bids is hereby attached as Annex "A".*

**WHEREAS**, in accordance with Section 32.2.1 of the IRR of R.A. No. 9184, a detailed bid evaluation was conducted BACG through its Technical Working Group (TWG) and DBPSC passed and was declared as the Single Calculated Bid for Lots 1 and 2.

**WHEREAS**, on 16 July 2018, the TWG conducted post-qualification evaluation of DBPSC to determine whether it is compliant with, and is responsive to the requirements and conditions specified in the Bidding Documents.

**WHEREAS**, upon post-qualification conducted by the TWG and after careful examination, validation and verification of all the eligibility, technical and financial documents submitted by DBPSC, its bid has been found Complying and Responsive. *The Post-Qualification Report is hereby attached as Annex "B"*.

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

2. To declare **DBP SERVICE CORPORATION** as the bidder with the Single Calculated and Responsive Bid for the BIDDING FOR MANPOWER SERVICES FOR THE BCDA UNDER A TWO-YEAR SERVICE AGREEMENT (CONSISTING OF TWO LOTS);
3. To award the Contract to **DBP SERVICE CORPORATION** for both Lots in the following amounts inclusive of all applicable taxes and fees:
  - a. Lot 1: Manpower Services for General Support and Janitorial Services in the amount of **Php18,886,790.40**, inclusive of all applicable taxes and fees; and
  - b. Lot 2: Manpower Services for Technical and Administrative Support Services in the amount of **Php53,649,172.80**, inclusive of all applicable taxes and fees.
4. To issue the Notice of Award to **DBP SERVICE CORPORATION** (*copy attached*); and,
5. To direct the Office of the Organization Development & Management Department, being the end-user unit, to furnish the BAC for Goods copies of the duly conformed Notices of Award, Notices to Proceed and the duly executed agreements/contracts.
