SIX-MONTH LEASE OF HIGH-END NETWORK CAMERAS AND HIGH-DEFINITION (HD) SURVEILLANCE, RECORDING AND MONITORING SYSTEM

RESOLUTION NO. BG-2017-030

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) has put on bid the Six (6)-Month Lease of High-End Network Cameras and HD Surveillance, Recording AND MONITORING SYSTEM with an Approved Budget for the Contract (ABC) in the amount of Thirteen Million Two Hundred Thousand Pesos (Php13,200,000.00), inclusive of all applicable taxes, insurance and fees;

WHEREAS, the Bids and Awards Committee for Goods (BAC-G), through its Secretariat, advertised the Invitation to Bid in a newspaper of nationwide circulation on 07 July 2017 and posted the same in the BCDA website, DBM Philippine Government Electronic Procurement System (PhilGEPS) website and in a conspicuous place reserved for the purpose in the premises of BCDA continuously for seven (7) calendar days;

WHEREAS, in response to the said advertisements, one (1) prospective bidder purchased the bidding documents, namely, Comclark Network and Technology Corporation;

WHEREAS, no bid was received by the BCDA Central Receiving and Releasing Area (CRRA) by 1:00 PM of July 31, 2017, the set deadline of submission of bids, prior to the scheduled Bid Opening at 2:00 PM of the same day; one set of bid documents from Comclark Network and Technology Corporation was received by the CRRA at 1:39 PM of July 31, 2017, or thirty-nine (39) minutes late vis-à-vis the deadline; said set of bid documents was returned unopened to the representatives of Comclark Network and Technology Corporation who were present at the BCDA office for the scheduled opening of bids;

WHEREAS, the BAC-G declared failure of bidding pursuant to Section 35.1 of the Revised IRR of Republic Act No. 9184, to wit:

- 35.1 The BAC shall declare the bidding a failure when:
 - a. No bids are received; [emphasis supplied]
 - b. Xxxxxx

NOW, THEREFORE, We, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE** as it is hereby **RESOLVED**, to recommend the following:

- To confirm the BAC-G's declaration of FAILURE OF BIDDING for the SIX (6)-MONTH LEASE OF HIGH-END NETWORK CAMERAS AND HD SURVEILLANCE, RECORDING AND MONITORING SYSTEM:
- To conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, pursuant to Section 35 of the Revised IRR of RA 9184, especially considering that only one (1) out of seven (7) who attended the pre-bid
