**BID BULLETIN NO. 9**

**TO ALL PROSPECTIVE PRIVATE SECTOR PARTICIPANTS:**

Capitalised terms used and not otherwise defined in this Bid Bulletin No. 9 shall have the meaning given to them in the Instructions to Private Sector Participants: Volume 1 - Eligibility Documents issued by the Joint Venture Selection Committee of the Bases Conversion and Development Authority on 16 May 2018, as amended, for the Competitive Selection for the Joint Venture Development of the Electric Power Distribution System in New Clark City.

This Bid Bulletin No. 9 is being issued to inform all prospective PSPs that:

1. The Consortium of **MERALCO Marubeni Consortium**, composed of Consortium Members - Manila Electric Company and Marubeni Corporation, has met all of the Eligibility Requirements. In accordance with IPSP: Volume 1 — Eligibility Documents, **MERALCO Marubeni Consortium** is declared a Provisionally-Eligible PSP. Its declaration as an Eligible PSP shall be contingent upon its submission of the Notarized Authority to Participate in the Consortium and Apply to be Declared Eligible and Bid, and Designation of Lead Member and Authorized Representative of Consortium (using the form prescribed in Annex EPF-2B of IPSP: Volume 1 - Forms and Annexures) of **Marubeni Corporation**, no later than Post-Eligibility Documents Submission Date and in accordance with Section 4.1.2 of IPSP: Volume 1 — Eligibility Documents.
2. The Consortium of **Aboitiz – KEPCO Consortium**, composed of Consortium Members - Olongapo Energy Corporation and KEPCO Philippines Corporation, has met all of the Eligibility Requirements. In accordance with IPSP: Volume 1 — Eligibility Documents, **Aboitiz – KEPCO Consortium** is declared a Provisionally-Eligible PSP. Its declaration as an Eligible PSP shall be contingent upon its submission of the acknowledged and/or authenticated Certificate on Validity of Hyosung's License for Construction Business, listed in paragraph 5 of the Consortium's EPF-1 (copies of which were submitted to the JVSC on the Eligibility Documents Submission Date) no later than Post-Eligibility Documents Submission Date and in accordance with Section 2.9.5 of IPSP: Volume 1 — Eligibility Documents.


Pursuant to to IPSP: Volume 1, the two PSPs are allowed to proceed to Stage 2 of the Competitive Selection Process governed by Volume 2 of IPSP. IPSP: Volume 2 – Competitive Selection Documents, Forms and Annexures shall be made available to the two PSPs starting 30 July 2018.

Nothing in this Bid Bulletin No. 9 shall be construed as a waiver of the PSPs' obligations and responsibilities or the BCDA and JVSC's rights and prerogatives including, but not limited to, the JVSC's right under Section 2.1 of IPSP: Volume 1 — Eligibility Documents to verify at any time during the Competitive Selection Process the documents and information submitted by the PSPs.

If any one of the provisions of this Bid Bulletin No. 9 is held invalid, illegal or unenforceable, the validity, legality or enforceability of the remaining provisions will not be affected thereby.
