BID BULLETIN NO. 8 (NOTICE OF RESUMPTION OF BIDDING ACTIVITIES)

In accordance with Section 8 of the GPPB Resolution No. 09-2020 dated 7 May 2020 and Bid Bulletin No. 7 dated 22 May 2020, the suspension of Post-Qualification and the subsequent bidding activities for the Construction of Special and Technical Staff (STS) Building for Special Service Center (SSC) and Division Administration Command Center (DACC) is hereby lifted effective 15 June 2020.

The BAC-I has determined that the conduct of bidding activities for the project, specifically the Post-Qualification including the necessary verifications from concerned agencies, can already be resumed pursuant to the national government's pronouncement on the implementation of community quarantine which placed the National Capital Region (NCR) and the locations of the projects that need further verification under General Community Quarantine (GCQ) since 1 June 2020. Relative thereto, the schedules of the resumption of Post-Qualification as well as the subsequent bidding activities are reflected in the attached revised Timetable of Bidding Activities for the Project.

This Bid Bulletin supersedes, modifies or amends the provisions of existing or previous Bid Bulletins on the Project that are inconsistent herewith.
