The Bases Conversion and Development Authority (BCDA) hereby awards the contract to Catalina Security Agency, for having submitted the Lowest Calculated and Responsive Bid for the Procurement of Security Services for AOR II (Fort Bonifacio-Open Area) in the amount of Nineteen Million Three Hundred Eighty Four Thousand Two Hundred Seventy Five Pesos and 12/100 (Php19,384,275.12) and for AOR IV-A (BCDA Clark Facilities) in the amount of Seven Million Two Hundred Sixty-Three Thousand One Hundred Eighty-Eight Pesos and 52/100 (Php7,263,188.52), respectively, inclusive of all applicable taxes and fees.
