BAC-C Resolution Declaring Failed Bidding

Consulting Services for the Establishment of a Competency-Based Human Resource System for BCDA based on the BCDA Competency Framework

WHEREAS, on December 22, 2016, pursuant to the request of the Organization Development and Management Department (ODMD), the Bids and Awards Committee for Consulting Services (BAC-C) issued BAC Resolution No. BC-2016-064 recommending the procurement of the Consulting Services for the Establishment of a Competency-Based Human Resource System for BCDA based on the BCDA Competency Framework (the Project) through Section 53.9, Small Value Procurement under the Alternative Methods of Procurement of the Revised IRR of RA 9184;

WHEREAS, the same resolution delegated to ODMD, as end-user, the procurement of the above-mentioned consulting services, pursuant to Section IV.J. of Annex H, Consolidated Guidelines for the Alternative Methods of Procurement (consolidated guidelines), subject to compliance with the applicable provisions of RA 9184;

WHEREAS, in a memo dated March 15, 2017, the ODMD reported to the BAC-C that the two proponents who submitted their proposals but failed to pass the minimum requirements are as follows:

- a. Clearvision Outsourcing Consultants (Clearvision)
- b. JMDY Competency-Based Executive Coaching Services (JMDY);

WHEREAS, Clearvision failed in the requirement of at least five (5) years relevant experience, while JMDY failed in the requirements of (1) "at least three (3) years of experience conducting a similar engagement for major companies" and (2) "similar engagement with at least one (1) government institution," with no similar projects and no similar engagement in government, respectively;

WHEREAS, using a non-discretionary "pass/fail" criterion, both proponents were rated failed by the ODMD in the minimum qualifications required;

WHEREAS, pursuant to Section 35 of the Revised IRR of RA 9184, the BAC-C declared a FAILURE OF BIDDING for reasons stated above;

WHEREAS, a review of the Terms of Reference (TOR) was conducted by ODMD and based on the review, the President and CEO approved the revised TOR;

WHEREAS, in the same memo dated March 15, 2017, the ODMD requested for the reposting of the procurement pursuant to Section 53.9, Small Value Procurement of the Revised IRR;

- 1. To declare a failure of bidding for the procurement of Consulting Services for the Establishment of a Competency-Based Human Resource System for BCDA based on the BCDA Competency Framework;
- 2. To request for authority from the President and CEO to rebid the procurement of consulting services for the said Project through Small Value Procurement based on Section 53.9 of the Revised IRR for the said project:
- To delegate the procurement of the aforesaid consulting services to the BCDA ODMD, as the end-user, subject to compliance with the applicable provisions of RA 9184:
- 4. To direct the ODMD to furnish the BAC-C Secretariat copies of the duly conformed Notice of Award, Notice to Proceed and the executed Contract, and all supporting documents pursuant to the procurement; and
- 5. In the event that the procurement of said consultancy services fails, to direct the enduser to report to the BAC-C, through a memo, the result of the procurement process within a period of 15 days upon determination that the procurement has failed.
