**BIDDING FOR THE CONSTRUCTION OF AIRPORT-NCC ACCESS ROAD Phase 2
(Aranguren-Dapdap) and Phase 3 (Dapdap-Calumpang) Segments**

BID BULLETIN NO. 5

This Bid Bulletin clarifies matters relative to the Bidding for the Construction of Airport-NCC Access Road Phase 2 (Aranguren-Dapdap) and Phase 3 (Dapdap-Calumpang) Segments.

1. Clarifications from SBAC

a. Clause 5.1 of the Bid Data Sheet (BDS) in the bidding documents of Phase 2 and Phase 3 is modified as follows:

Those with on-going projects/contracts with BCDA and its subsidiaries with a negative slippage at the time of bid submission; and 2. Those who have been awarded the following projects: <ol style="list-style-type: none"> a. Construction of New Clark City to SCTEx Access Road Project; b. Construction of Airport to NCC Access Road (Phase 1); c. Construction of the Terrestrial of the Cable Network Corridor for the Luzon Bypass Infrastructure Project – Segment A (Aurora to Pangasinan); and 	<p>The bidders/contractors, and/or their consortium or joint venture members/partners with on-going projects/contracts with BCDA or its subsidiaries <u>with a negative slippage at the time of bid submission</u> are disqualified in the subject bidding. (underscoring ours)</p> <p>The bidders/contractors, and/or their consortium or joint venture members/partners that are declared disqualified/blacklisted/suspended by BCDA or its subsidiaries are likewise disqualified in the subject bidding.</p> <p>A bidder shall submit only one (1) bid for only one (1) project or phase, either Phase 2 or 3. Thus, a prospective bidder must have completed a project similar to the project that the bidder has selected to bid for and the similar project must have a contract amount of not less than fifty</p>

- d. Construction of the Terrestrial of the Cable Network Corridor for the Luzon Bypass Infrastructure Project – Segment B (La Union to Pangasinan).

A bidder shall submit only one (1) bid for only one (1) project or phase, either Phase 2 or 3. Thus, a prospective bidder must have completed a project similar to the project that the bidder has selected to bid for and the similar project must have a contract amount of not less than fifty percent (50%) of the ABC of such project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

- b. The Bid and Bid Security should be valid up to 120 calendar days from the date of Opening of Bids.
- c. The bidders may submit a certified true copy of the documents required of their Consortium/JV foreign partners that are consularized/authenticated in the Philippine Embassy in the country of origin **or** the bidders may submit a copy of the original documents required provided that the bidders certify through the Omnibus Sworn Statement that the document submitted is an authentic copy of the original, it is complete, and the information and statements therein are true and correct. **However**, the original documents should be presented during Post-Qualification for verification, validation, and ascertaining of the authenticity of the submitted copies.

2. Reminders from SBAC

- a. The **deadline for the submission** of Eligibility Documents and Financial Proposals for the Bidding for the Construction of Airport-NCC Access Road **Phase 2 (Aranguren-Dapdap) Segment** is at **9:00AM on 11 April 2019** at the BCDA Central Receiving and Releasing Area (CRRRA) located at the 2nd Floor Bonifacio Technology Center, 31st St. cor. 2nd Avenue Bonifacio Global City, Taguig City. **Late bids or those submitted after 9:00AM of 11 April 2019 shall not be accepted.**
- b. The **Opening of Bids** for the Bidding for the Construction of Airport-NCC Access Road **Phase 2 (Aranguren-Dapdap) Segment** shall be at **10:00AM on 11 April 2019** at the BCDA Corporate Center, 2nd Floor Bonifacio Technology Center, 31st St. cor. 2nd Avenue Bonifacio Global City, Taguig City.

- c. The **deadline for the submission** of Eligibility Documents and Financial Proposals for the Bidding for the Construction of Airport-NCC Access Road **Phase 3 (Dapdap-Calumpang) Segment** is at **9:00 AM on 12 April 2019** at the BCDA Central Receiving and Releasing Area (CRRA) located at the 2nd Floor Bonifacio Technology Center, 31st St. cor. 2nd Avenue Bonifacio Global City, Taguig City. **Late bids or those submitted after 9:00 AM of 12 April 2019 shall not be accepted.**
- d. The **Opening of Bids** for the Bidding for the Construction of Airport-NCC Access Road **Phase 3 (Dapdap-Calumpang) Segment** shall be at **10:00 AM on 12 April 2019** at the BCDA Corporate Center, 2nd Floor Bonifacio Technology Center, 31st St. cor. 2nd Avenue Bonifacio Global City, Taguig City.

Deadline for Clarifications was on 29 March 2019. The interested bidders can still inquire some small details from BAC Secretariat even beyond the deadline for clarifications as long as the matter being asked will not affect the Terms of Reference (TOR) of the project and bids of other bidders.

Last day of issuance of Supplemental/Bid Bulletin, if any, is on **4 April 2019**.

All provisions, conditions and statements in the bidding documents inconsistent with this Bid Bulletin are either modified or rendered ineffective, as the case may be.
