

**BAC-C RESOLUTION NO. BC2019-033**

**DECLARATION OF THE BIDDER WITH THE HIGHEST RATED BID (HRB)**

**Construction Management and Supervision (CMS) of the Airport (CIA) to New Clark City (NCC) Access Road Phase 3 (Dapdap-Calumpang Segment)**

**WHEREAS**, on 12 April 2019, BCDA advertised the request for Expression of Interest (REI) for the said consulting services in the BCDA website, PhilGEPS website and in a conspicuous place in the premises of BCDA continuously for seven (7) calendar days;

**WHEREAS**, the consulting services has an approved Budget for the Contract (ABC) amounting to **Pesos: Sixty Five Million Eight Hundred Fifty Six Thousand and 00/100 (Php65,856,000.00)**, inclusive of all applicable taxes and fees, to be completed within twenty-one (21) months;

**WHEREAS**, on 21 June 2019, the Bids and Awards Committee for Consulting Services (BAC-C) issued BAC-C Resolution No. BC-2019-016, declaring the following bidders as **SHORTLISTED** and **ELIGIBLE** to proceed to the next stage of the bidding process:

- a. Joint Venture between Design Science, Inc. (DSI) and Philipps Technical Consultants Corporation (PTCC);
- b. Joint Venture between KEA Asia, Inc. (KEA) and Foresight Development and Surveying Company (FDSC); and
- c. TCGI Engineers;

**WHEREAS**, the evaluation procedure adopted to be declared as the bidder with Highest Rated Bid (HRB) was the Quality-Cost Based Evaluation (QCBE) procedure. The consultant must pass the required 70% minimum technical score;

**WHEREAS**, the abovementioned consulting firms submitted their Technical and Financial Proposals before the deadline of submission of bids on 03 September 2019 at 9:30AM;

**WHEREAS**, on the same day, at 10:30AM, the technical proposals were opened and evaluated based on the approved detailed evaluation criteria where the required minimum score is 70%. The results were as follows:

**WHEREAS**, on 16 September 2019, the BAC-C proceeded with the opening of the financial proposals of bidders who passed the required minimum score for technical proposal of 70%;

**WHEREAS**, all financial bids were found to be within the ABC;

**WHEREAS**, the results of the combined Technical & Financial evaluation and ranking of the bidders are as follows:

DECLARE the **Joint Venture between KE Asia, Inc. and Foresight Development and Surveying Company** as the bidder with the **Highest Rated Bid (HRB)** for the Consulting Services for the Construction Management and Supervision (CMS) of the Airport (CIA) to New Clark City (NCC) Access Road Phase 3 (Dapdap-Calumpang Segment); and
2. PROCEED with the negotiations and undergo post qualification of said bidder in accordance with Section 32.2.5 and Sec. 34 of the IRR of RA 9184, respectively.
