Consulting Services for the Production of the BCDA 2023 Annual Report

RESOLUTION NO. 2023-013
(Declaration of Shortlisted Consultants)

WHEREAS, the Bases Conversion and Development Authority (BCDA) is mandated under Republic Act No. 7227, as amended by Republic Act No. 7917, to accelerate the sound and balanced conversion into alternative productive uses of the Clark and Subic military reservations and their extensions, to raise funds by the sale of portions of Metro Manila Military Camps and to apply said funds for the development and conversion into alternative productive uses of these properties;

WHEREAS, on **19 September 2023**, the BCDA, through its Bids and Awards Committee for Consulting Services (BAC-C), posted a Request for Expression of Interest (REI) including the bidding documents in PhilGEPS, the BCDA Website, and in a conspicuous place within the premises of BCDA for the **Consulting Services for the Production of BCDA 2023 Annual Report** under Section 10 - Competitive Bidding of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184, with an Approved Budget for the Contract (ABC) in the amount of **Pesos: One Million Eight Hundred Thousand and 00/100 (PhP 1,800,000.00)**, inclusive of all applicable taxes and fees;

WHEREAS, in response to the said advertisement of the REI and bidding documents, two (2) prospective bidders submitted their Eligibility Documents for the **Consulting Services for the Production of BCDA 2023 Annual Report** prior to the set deadline for submission on 09 October 2023 at 9:00 a.m., to wit:

- 1) Studio 5 Designs, Inc.; and
- 2) Mode Matrix Manila, Inc.

WHEREAS, Section 30.1 of the 2016 Revised IRR of RA 9184 provides:

“xxx... the BAC shall check the submitted documents of each bidder against a checklist of required documents to ascertain if they are all present, using a non-discretionary “pass/fail” criterion, as stated in the Instructions to Bidders. If a bidder submits the required document, it shall be rated “passed” for that particular requirement. In this regard, bids that fail to include any

requirement or are incomplete or patently insufficient shall be considered as “failed.” xxx”

WHEREAS, the submitted Eligibility Documents of the said prospective bidders were subjected to detailed evaluation and shortlisting on 09 October 2023 to 16 October 2023 in accordance with Section 24 of the 2016 RIRR of R.A. 9184, and using the criteria and rating system for shortlisting as provided under item number 9.2 of Eligibility Data Sheet (EDS) for the project;

WHEREAS, the Technical Working Group (TWG) presented the results of the evaluation of the Eligibility Documents and shortlisting, and the BAC-C deliberated on the results on 17 October 2023;

WHEREAS, the results of the Evaluation/Eligibility Check and Shortlisting show that two (2) out of two (2) prospective bidders were rated **“PASSED”** having complied with the requirements provided under the Eligibility Documents and Terms of Reference for the consulting services, and 2016 RIRR of RA No. 9184, to wit:

NOW, THEREFORE, foregoing considered, We, the Members of the BAC-C, hereby RESOLVE to recommend the following:

- 1) Declare **Studio 5 Designs, Inc.**, who were rated **“PASSED”**, as **ELIGIBLE** and **SHORTLISTED** to proceed to the next stage of the bidding for the consulting services pursuant to Section 24.5.4 of 2016 RIRR of RA 9184; and
- 2) Declare **Mode Matrix Manila, Inc.**, who were rated **“PASSED”**, as **ELIGIBLE** and **SHORTLISTED** to proceed to the next stage of the bidding for the consulting services pursuant to Section 24.5.4 of 2016 RIRR of RA 9184;
- 3) Issue a Notice of Eligibility and Shortlisting to the aforementioned Eligible and

Shortlisted prospective bidders to attend the Pre-bid Conference for the **Consulting Services for the Production of BCDA 2023 Annual Report**; and

- 4) Approval of the President and Chief Executive Officer of the foregoing findings.


