**RESOLUTION NO. BG-2023-061  
(FAILURE OF BIDDING)**

**WHEREAS**, the **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)**, through the 2023 General Appropriations Act (GAA), has bid out the **Procurement of the Operation and Maintenance of the New Clark City Sports Facilities: Lease of Timing and Scoring System and Services for the Aquatics Center in the National Government Administrative Center (NGAC) for the Hosting of the Asian Age Group Championships** with an Approved Budget for the Contract (ABC) of **FIVE MILLION PESOS (Php5,000,000.00)**, inclusive of VAT and all other applicable government taxes, fees, and charges.

**WHEREAS**, the Bids and Awards Committee for Goods (BAC-G) advertised/posted the Invitation to Bid, including the bidding documents on 22 November 2023 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

**WHEREAS**, BAC-G has conducted a Pre-bid Conference on 01 December 2023, which was attended by two (2) prospective bidders from Amigo Entertainment Technologies and Wilsen WSL;

**WHEREAS**, BAC-G issued Bid Bulletin No. 1 dated 11 December 2023 concerning the Change of Schedule, specifically the deadline for the Submission of Bid Documents and Opening of Bids;

**WHEREAS**, no bid was received upon the lapse of the deadline for submission of bids on 18 December 2023, 12:00 NN;

**WHEREAS**, BAC-G declared a failure of bidding for the **Procurement of the Operation and Maintenance of the NCC Sports Facilities: Lease of Timing and Scoring System and Services for the Aquatics Center in the National Government Administrative Center (NGAC) for the Hosting of the Asian Age Group Championships** pursuant to Section 35.1 of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) No. 9184, to wit:

*"35. 1. The BAC shall declare the bidding a failure when:*

*a) No bids received;*

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**, to recommend the following:

1. To declare a Failure of Bidding for the **Procurement of Operation and Maintenance of the New Clark City Sports Facilities: Lease of Timing and Scoring System and Services for the Aquatics Center in the National Government Administrative Center (NGAC) for the Hosting of the Asian Age Group Championships** in accordance with Section 35.1 of the 2016 RIRR of RA 9184 ; and
2. To direct the Information and Communication Technology Department (ICTD), as the end-user unit, to conduct a mandatory review and evaluation of the terms, conditions, and specifications of the bidding documents, including the cost estimates, and other requirements relative to this procurement, pursuant to Section 35.2 of the 2016 RIRR of RA 9184.
