**Procurement for the Replacement of Major Components of Ventilation
and Air Conditioning System at BCDA Office, Bonifacio Technology Center**

RESOLUTION No. BG-2023-012

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through its 2023 Corporate Operating Budget (COB), applied the sum of **One Million Nine Hundred Thirty-Eight Thousand Nine Hundred Pesos & 00/100 Only (Php1,938,900.00)**, inclusive of VAT and all other applicable government taxes, fees, and charges as the Approved Budget for the Contract (ABC) for the **Procurement for the Replacement of Major Components of Ventilation and Air Conditioning System at BCDA Office, Bonifacio Technology Center**;

The copy of the approved Bids and Awards Committee for Goods (BAC-G) Annual Procurement Plan for CY 2023 is hereto attached as "Annex A"

WHEREAS, the Bids and Awards Committee for Goods (BAC-G), through its Secretariat, advertised the Invitation to Bid on 23 March 2023 in the following:

1. DBM Philippine Government Electronic Procurement System (PhilGEPS);
2. BCDA Website; and
3. Conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, the BAC-G conducted the Pre-bid Conference on 30 March 2023 at 10:00 AM at the BCDA Corporate Center, Bonifacio Global City, Taguig City which was attended by four (4) prospective bidders;

- a. Amigo Tech.;
- b. 3G Powerplus;
- c. RVENT HVAC Solution, Inc; and
- d. Dual Air, Inc.

WHEREAS, in response to said advertisements, only one (1) bidder, **Dual Air Inc.**, submitted its bid for the project before the deadline of submission on 24 April 2023 (Monday) at 12:00 PM at the BCDA Corporate Center, Bonifacio Global City, Taguig City;

WHEREAS, during the 24 April 2023 (Monday) Opening of Bids at the BCDA Corporate Center, Bonifacio Global City, Taguig City, BAC-G received and opened the bid from the above-mentioned bidder and noted that Dual Air, Inc. passed both the eligibility and technical requirements;

WHEREAS, Dual Air Inc. submitted a financial bid of **One Million Nine Hundred Sixteen Thousand Three Hundred Twenty-One Pesos and 36/100 (Php1,916,321.36)**, inclusive of all applicable taxes and fees, which is below the ABC. Thus, the BAC-G declared **Dual Air Inc.** as the Single Calculated Bidder (SCB) for the project;

WHEREAS, in view of the foregoing and consistent with Section 34 of Rule X – Post-Qualification of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, the BAC-G Technical Working Group (TWG) conducted a Post-Qualification of **Dual Air Inc.** on 03-08 May 2023 to determine if **Dual Air Inc.** is compliant and responsive to the requirements and conditions

WHEREAS, based on the results of the post-qualification, the TWG found **Dual Air Inc.** compliant with and responsive to the eligibility, technical, and financial requirements of the project;

The Post-Qualification Report is hereby attached as "Annex D".

WHEREAS, in the 09 May 2023 (Tuesday) deliberation of the BAC-G, the BAC-G concurs with the recommendation of the TWG that **Dual Air Inc.** is eligible, technically, and financially capable to undertake the project.

ACCORDINGLY, we, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**:

1. To declare **Dual Air Inc.** as the Single Calculated and Responsive Bidder (SCRB) for the **Replacement of Major Components of Ventilation and Air Conditioning System at BCDA Office, Bonifacio Technology Center;**
2. To award the contract to **Dual Air Inc.** with the amount of **One Million Nine Hundred Sixteen Thousand Three Hundred Twenty-One Pesos and 36/00 (Php1,916,321.36)**, inclusive of VAT and all applicable government taxes and fees; and
3. To direct the **Property and Procurement Management Department - General Services Division (PPMD - GSD)**, being the end-user unit, to submit to the BAC-G the duly conformed Notice of Award, Notice to Proceed, and the duly executed agreement/contract.
