**RESOLUTION NO. 2023-05**

**(Declaration of Single Calculated and Responsive Bid)**

**WHEREAS**, the Bases Conversion and Development Authority (BCDA) is mandated under Republic Act No. 7227, as amended by Republic Act No. 7917, to accelerate the sound and balanced conversion into alternative productive uses of the Clark and Subic military reservations and their extensions, to raise funds by the sale of portions of Metro Manila Military Camps, and to apply said funds for the development and conversion into alternative productive uses of these properties;

**WHEREAS**, on **27 October 2023**, the BCDA, through its Special Bids and Awards Committee for the National Academy of Sports (SBAC-NAS), posted an Invitation to Bid (ITB), including the bidding documents, on the Philippine Government Electronic Procurement System (PhilGEPS), the BCDA Website, and a conspicuous place within the premises of BCDA for the **Procurement of the Supply, Delivery, and Installation of Sports Science and Sports Medicine Equipment for the National Academy of Sports Phase 2 at New Clark City** under Section 10 - Competitive Bidding of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184, with an Approved Budget for the Contract (ABC) in the amount of **Php60,680,000.00**, inclusive of all applicable taxes and fees;

**WHEREAS**, the SBAC-NAS issued a Bid Bulletin on 07 November 2023 to clarify queries about the eligibility, technical, and financial requirements raised by the bidders during the pre-bid conference conducted on 27 October 2023, sent via letters, and emails;

**WHEREAS**, in response to the said advertisement of ITB and bidding documents, one (1) bidder, **APActivePro Trading**, bought and submitted its bid documents prior to the set deadline of submission of bids for the project on 14 November 2023, 9:00 am;

**WHEREAS**, Section 30.1 of the 2016 Revised IRR of RA 9184 provides:

*“xxx.. the BAC shall check the submitted documents of each bidder against a checklist of required documents to ascertain if they are all present, using a non-discretionary “pass/fail” criterion, as stated in the Instructions to Bidders. If a bidder submits the required document, it shall be rated “passed” for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as “failed.” xxx”*

**WHEREAS**, on 14 November 2023, the envelopes containing the Eligibility and Technical Requirements of the aforementioned bidder were opened and subjected to a preliminary examination by determining the presence or absence of the required documents using “pass/fail” criterion. The SBAC-NAS found that **APActivePro Trading** has “**PASSED**” the preliminary examination of the eligibility/technical requirement:

**WHEREAS**, the “second envelope” which contained the financial proposal of **APActivePro Trading** that “passed” the preliminary examination of the eligibility/technical requirement was opened and was likewise subjected to a preliminary evaluation. Its bid amounts is as follows:

**WHEREAS**, pursuant to Sec 30 of the Revised Implementing Rules and Regulations (IRR) of RA 9184:

*“Only bids that are determined to contain all the bid requirements for both components shall be rated passed and shall immediately be considered for evaluation and comparison.”*

Further, Sec. 32.2.1 of the bid document states that the detailed evaluation shall consider the (a) completeness of the bid; and (b) the arithmetical corrections. Relative thereto, the bid envelopes of **APActivePro Trading** that was rated “PASSED” was considered for the detailed evaluation;

**WHEREAS**, pursuant to Sec. 30 of the Revised Implementing Rules and Regulations (RIRR) of RA 9184, the SBAC-NAS Technical Working Group (TWG) conducted a detailed evaluation of the technical and financial proposals from 15-20 November 2023 to determine if **APActivePro Trading**'s bid is the Single Calculated Bid (SCB):

**WHEREAS**, in order to establish the correct calculated prices of the bids in the Financial Proposals of the one bidder, Section 32.2.3 of the revised IRR of RA 9184 shall apply on arithmetical corrections. The following is the result of the detailed evaluation of the Financial Proposals of the lone bidder:

**WHEREAS**, on 21 November 2023, the TWG presented the results of the detailed evaluation of the technical and financial proposals, and the SBAC deliberated on the results; **(Annex A)**

**WHEREAS**, based on the detailed evaluation of the technical and financial proposals by the TWG, SBAC-NAS hereby determined **APActivePro Trading** as the bidder with the **Single Calculated Bid (SCB)**, and recommended the same bidder to undergo a post-qualification process, pursuant to Section 34 of the RIRR of R.A. 9184.

**WHEREAS**, from 23 November to 04 December 2023, BCDA conducted a post qualification of **APActivePro Trading** to verify and confirm the veracity of its submitted eligibility, technical, and financial proposals;

**WHEREAS**, on 04 December 2023, the SBAC conducted a deliberation of the results of the post-qualification of **APActivePro Trading**. After careful examination, validation, and verification of all the submitted eligibility, legal, technical and financial documents, the SBAC-TWG found it to be compliant and responsive to the requirements stipulated in the bidding documents and recommended it as the bidder with the Single Calculated and Responsive Bid (SCRBI) for the Project based on its Post-Qualification Report; **(Annex B)**

**WHEREAS**, **APActivePro Trading** is not "blacklisted" or barred from bidding by the Government of the Philippines or any of its agencies, offices, corporations or local government units, as reflected in the consolidated GPPB List of Blacklisted Contractors as of 01 December 2023;

**WHEREAS**, on 07 December 2023, the BCDA Board, being the Head of the Procuring Entity [HoPE], after having heard and assessed the results of the post qualification, approved the recommendation of the SBAC-NAS to award the contract to **APActivePro Trading** for this project;

**NOW, THEREFORE**, foregoing considered and after careful evaluation and thorough deliberation of the bids submitted for the Project, we, the Members of the Special Bids and Awards Committee (SBAC) for the Procurement of the Supply, Delivery, and Installation of Sports Science and Sports Medicine Equipment for the

National Academy of Sports (NAS) Phase 2 at New Clark City, hereby **RESOLVE** to recommend the following:

1. To award the contract to **APActivePro Trading** as the bidder with the Single Calculated and Responsive Bid (SCRB) for the **Supply, Delivery, and Installation of Sports Science and Sports Medicine Equipment for the National Academy of Sports (NAS) Phase 2 at New Clark City** with the amount of **Fifty Nine Million Seventy Five Thousand Pesos and 00/100 Only (Php59,075,000.00)**, inclusive of all applicable government taxes and fees, pursuant to Sec. 34.4 of the revised IRR of RA 9184; and
2. To issue the corresponding Notice of Award (NOA) to **APActivePro Trading**, being the bidder with SCR.B.
