The Bases Conversion and Development Authority (BCDA) hereby awards the contract to **STAGE CRAFT INTERNATIONAL, INC.**, as the Single Calculated and Responsive Bidder (SCRB), for Lot 2 (Retractable Seating System) and Lot 3 (Fabricated Items) for the **PROCUREMENT OF THE OPERATION AND MAINTENANCE OF THE NEW CLARK CITY SPORTS FACILITIES: SUPPLY, DELIVERY, AND INSTALLATION OF ADDITIONAL SPORTS EQUIPMENT AND FACILITY ACCESSORIES, RETRACTABLE SEATING SYSTEM AND FABRICATED ITEMS FOR THE AQUATIC CENTER IN THE NATIONAL GOVERNMENT ADMINISTRATIVE CENTER FOR THE HOSTING OF THE ASIAN AGE GROUP CHAMPIONSHIPS** in the amount of Nine Million Nine Hundred Sixty Thousand Pesos and 00/100 Only (Php9,960,000.00) for Lot 2, and Five Million Seven Hundred Forty Five Thousand and Four Hundred Pesos (Php5,745,400.00) for Lot 3, inclusive of VAT and all applicable taxes and fees.

You are therefore required, within ten (10) calendar days from receipt of this Notice of Award, to:

1. Formally enter into contract with BCDA and comply with all the documentary requirements; and,
2. Submit a duly notarized Performance Securing Declaration or post a Performance Security denominated in Philippine Peso in any of the form and in the amount stipulated in Section 39.2 of the revised IRR of RA 9184 which shall be posted in favor of BCDA and which shall remain valid until the issuance of Certificate of Final Acceptance, as follows:
