You are therefore required, within ten (10) calendar days from receipt of this Notice of Award, to:

- 1. Formally enter into contract with BCDA and comply with all the documentary requirements; and,
- Submit a duly notarized Performance Securing Declaration or post a Performance Security denominated in Philippine Peso in any of the form and in the amount stipulated in Section 39.2 of the revised IRR of RA 9184 which shall be posted in favor of BCDA and which shall remain valid until the issuance of Certificate of Final Acceptance, as follows:
