1.	Final and approved color of the vehicles to be proposed by the prospective bidders.	The preferred colors of BCDA for the motor vehicles to be procured are the following: Lot A: Multi Purpose Vehicle (MPV) Black Lot B: Sports Utility Vehicle (SUV) Pearl White Sparkling Black
2.	Are the Official Receipt (OR) and Certificate of Registration (CR) required upon the delivery of the motor vehicles? This is connection with the standard process from the Land Transportation Office (LTO) with regards to the availability and processing of the OR/CR.	BCDA requires the winning bidder to provide the Official Receipt (OR) and Certificate of Registration (CR) of the motor vehicles within one (1) month from the delivery.
3.	If the prospective bidders will participate for Lots A & B, do they have to pay only the Php25,000.00 fee in purchasing the bidding documents?	Yes.
