This bid bulletin clarifies the queries/questions raised during the Pre-eligibility Conference held on 10 February 2025 and written clarifications received through email pertaining to the above-cited consulting services.

I. QUERIES/QUESTIONS BY THE PROSPECTIVE BIDDERS

a. Queries/Questions raised during the Pre-eligibility Conference

Queries/Questions	Clarifications/Responses
1. Can we have a recorded copy of this conference?	The BAC-C cannot provide a copy of the recording of the Pre-Eligibility conference. Instead, the pre-eligibility conference presentation has been incorporated into Item I of Bid Bulletin No. 1, for your reference.
2. Does Camp John Hay have an existing Environmental Compliance Certificate (ECC)?	Yes. The existing ECC was issued on 26 January 1998 under the name of BCDA's former lessee. It covers the development and operation of an integrated eco-tourism and multi-use development complex on a 247-hectare property of the BCDA. BCDA and JHMC are currently processing the transfer of the ECC under the name of BCDA.
3. Do you have a recent ECC because the baseline data will no longer be used for the amendment of the ECC? It is due to the reason that we have been given only 270 days and one of the deliverables is an amended ECC, which the Consultant will provide. How much is the surety that we will give you within that period of time considering that the baseline data will be developed again?	Camp John Hay (CJH) has an existing ECC issued on 26 January 1998 under the name of BCDA's former lessee, which covers the development and operation of an integrated eco-tourism and multi-use development complex on a 247-hectare property of the BCDA. BCDA and JHMC are currently processing the transfer of the ECC under the name of BCDA. Under the terms of reference, the Consultant shall be responsible for securing a new or amended ECC to encompass the entire 625-hectare CJH Reservation, in accordance with the updated Master Development Plan. The Consultant shall work in coordination with BCDA to finalize the components to be included in

	the ECC application, ensuring alignment with the updated Master Plan. All activities related to the preparation, submission, and processing of the ECC shall be undertaken within the 270 calendar day (nine-month) contract duration.
4. One of the required key personnel is an Environmental Planner/Scientists. In the absence of the required license, can we consider our key personnel with a bachelor's degree in environmental science or environmental planning?	Please refer to Section II, amendment no. 3.
5. It is under Administrative Order No. 2000-28 that the implementing guidelines on engineering, ecological, and geohazard assessment as additional requirements for ECC application covering sloping ground subdivisions like sloping ground. So, it does not apply on the entire board development. It only applies if there is a plan for a subdivision or residential area. I would like to know because it will be a separate certificate. Please correct us. What is your advice on that?	The consultant shall be responsible for ensuring compliance with ECC requirements and for the preparation and submission of all reports necessary to obtain the ECC.
6. We would like to clarify regarding the topographical analysis. Are there specific levels of precision in terms of the contour lines to be generated? What specific output is needed for the topographical analysis?	Topographic data and other existing data that BCDA and JHMC have, will be provided to the winning bidder and shall be used as their baseline data for site analysis. In the event that there might be inconsistencies and invalid values in the dataset that the consultant may encounter, the consultant must verify and validate on the ground, and conduct additional topographic surveys, if necessary. There will be no specific level of precision as long as the topographic data to be used can satisfy the requirements to come up with the Site Development Plan and Feasibility Study for Select Areas that is up to 100 hectares.
