WHEREAS, on 27 August 2024, the BCDA Board, during the 664th Board Meeting, approved the renewal of the Contract of Lease with FBDC covering the period 01 November 2024 to 31 October 2027, with an approved Budget for the Contract (ABC) in the amount of One Hundred Nineteen Million Ninety-Three Thousand Four Hundred Eighty-Four Pesos and 63/100 (PhP119,093,484.63), exclusive of all applicable government taxes and fees, pursuant to Section V (D) - Negotiated Procurement, Item (9) - Lease of Real Property and Venue of Annex H - Consolidated Guidelines for the Alternative Methods of Procurement of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A.) No. 9184, also known as the "Government Procurement Reform Act";

NOW, THEREFORE, WE, the Members of the Bids and Awards Committee for Goods (BAC-G), hereby **RESOLVE**, as it is hereby **RESOLVED**, to recommend the renewal of the Contract of lease with FBDC and issuance of a notice of BCDA's intent to renew the contract of lease for three (3) years, or from 01 November 2024 to 31 October 2027, in the amount of One Hundred Nineteen Million Ninety-Three Thousand Four Hundred Eighty-Four Pesos and 63/100 (PhP119,093,484.63), exclusive of all applicable government taxes and fees.
