

NEW CLARK CITY ROAD MAINTENANCE SERVICES

CONTRACT AGREEMENT

This AGREEMENT made and entered into this ____ day of _____ 2025 between **BASES CONVERSION AND DEVELOPMENT AUTHORITY** of the Philippines, a government instrumentality vested with corporate powers, created by virtue of Republic Act No. 7227, as amended, with principal office address at the BCDA Corporate Center, 2nd Floor Bonifacio Technology Center, 31st Street, corner 2nd Avenue, Bonifacio Global City, Taguig City, represented herein by its President and Chief Executive Officer, **JOSHUA M. BINGCANG**, hereinafter called the **"the Entity"** of the one part and **VAG GENERAL MERCHANDISE**, a private entity duly organized and existing under the laws of the Republic of the Philippines, with office address Brgy. Gutad, Floridablanca, Pampanga, represented herein by its Authorized Representative, **VICTOR A. GADDI**, hereinafter called **"the Supplier"** of the other part.

WHEREAS, the Entity invited Bids for certain goods and ancillary services particularly for the **New Clark City Road Maintenance Services** and has accepted a Bid by the Supplier for the supply of those goods and services in the amount of **Twenty-Six Million Seven Hundred Thirty-Seven Thousand One Hundred Twenty-Three Pesos and 16/100 Only (PhP26,737,123.16)** (hereinafter called **"the Contract Price"**).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to;
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be attached, deemed to form, and be read and construed as part of this Contract, vis:
 - (a) Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of the Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - (b) Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the BCDA's bid evaluation;
 - (c) Performance Security;
 - (d) Notice of Award of Contract and the Bidder's conforme thereto; and
 - (e) Other contract documents that may be required by existing laws and/or the

Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **Twenty-Six Million Seven Hundred Thirty-Seven Thousand One Hundred Twenty-Three Pesos and 16/100 Only (PhP26,737,123.16)** or such other sums as may be ascertained, **VAG GENERAL MERCHANDISE** agrees to execute the New Clark City Road Maintenance Services in accordance with his/her/its Bid.
4. The BCDA agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.
