REBIDDING FOR THE SUPPLY, DELIVERY AND INSTALLATION OF SPORTS EQUIPMENT FOR THE NATIONAL ACADEMY OF SPORTS (NAS) – PHASE 1 AT NEW CLARK CITY

RESOLUTION NO. BG-SE-2022-01

The BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through the General Appropriations Act FY 2021 (validity extended pursuant to Republic Act No. 11640) has bid out the Rebidding for the Supply, Delivery and Installation of Sports Equipment for the National Academy of Sports (NAS) — Phase 1 at New Clark City with an Approved Budget for the Contract (ABC) of Nine Million Nine Hundred Ninety-Seven Thousand Pesos and 00/100 (PhP9,997,000.00), inclusive of all applicable taxes and fees;

WHEREAS, the Bids and Awards Committee for Goods (BAC-G), through its Secretariat, advertised/posted the Invitation to Bid including the bidding documents on 02 July 2022 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G conducted the Pre-bid Conference on 12 July 2022 which was attended by the following prospective bidders:

- a. Spurway Enterprises;
- b. Alpha Quality Express Inc.;
- c. Sol Sporting Goods;
- d. Crayons Sporting Goods Inc; and
- e. Pro Event

WHEREAS, BAC-G issued Bid Bulletin No. BAC-G-SE-2022-01 dated 26 July 2022 clarifying queries raised by the prospective bidders during the pre-bid conference and subsequently, via e-mail.

WHEREAS, in response to said advertisements, three (3) bidders, Spurway Enterprises, Crayons Sporting Goods Inc, and Pro Event submitted their bids before the deadline on 02 August 2022;

WHEREAS, during the Opening of Bids on 02 August 2022 at 10:00 AM, BAC-G received and opened the bids of the following bidders and noted the following observation:

WHEREAS, the three (3) bidders, Spurway Enterprises, Crayons Sporting Goods Inc., and Pro Event were declared eligible during the Opening of Bids. Thus, the financial proposals of the three bidders were opened, as shown in the table below:

WHEREAS, in the 08 August 2022 letter to Crayons Sporting Goods, Inc. and Pro Event, the BAC-G informed them of their ineligibility to proceed with the bidding;

WHEREAS, **Pro Event** in its 15 August 2022 letter to the BAC-G, filed a Motion for Reconsideration where they resubmitted additional brochures that improved their original bid by offering several free items and offering equipment with higher specifications than their original submission;

WHEREAS, in the 22 August 2022 letter to Pro Event, the BAC-G denied the Motion for Reconsideration filed by Pro Event reiterating the various reasons such as failure to comply with the minimum standard requirements of their original bid, non-compliance with the technical requirements and specifications which were also emphasized in the notice of ineligibility dated 08 August 2022. The BAC-G in its denial of the MR further emphasized that re-submission of additional brochures or modified documents after the deadline of submission of bids is not allowed as it constitutes an enhancement of the bid pursuant to Section 26.1 of the RIRR of RA 9184;

WHEREAS, the BAC-G recommended that Spurway Enterprises, being the Lowest Calculated Bidder, undergo a post qualification on 10-22 August 2022, pursuant to Section 34 of Rule X–Post-Qualification of the 2016 Revised Implementing Rules and Regulations (RIRR) of the Republic Act No. 9184;

WHEREAS, BAC-G deliberated on the results of the post-qualification and found that Spurway Enterprises is eligible, legally, technically, and financially capable to undertake the project;

The Post-Qualification Report is hereby attached as **Annex** "**C**".

NOW, THEREFORE, We, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**:









- To declare Spurway Enterprises as the Lowest Calculated and Responsive Bidder (LCRB) for the Rebidding for the Supply, Delivery and Installation of Sports Equipment for the National Academy of Sports (NAS) – Phase 1 at New Clark City;
- To award the contract for the Rebidding for the Supply, Delivery and Installation of Sports Equipment for the National Academy of Sports (NAS) Phase 1 at New Clark City to Spurway Enterprises in the amount of Nine Million Nine Hundred Ninety Thousand Two Hundred Fifty-Five Pesos and 60/100 (Php9,990,255.60), inclusive of VAT and all applicable taxes and fees; and
- 3. To direct the Special Projects Management Department (SPMD), being the end-user unit, to submit to the BAC-G the duly conformed Notice of Award, Notice to Proceed, and the duly executed agreement/contract during the prescribed period.
